If you or your child is sick or having symptoms of concern PLEASE STAY HOME!!!

If your child is not feeling well and experiencing symptoms including chill, repeated shaking with chills, muscle pain, body aches or other symptoms consistent with fever, temperature measured above 100.4°F, cough, congestion, sore throat, shortness of breath, headache, or new loss of taste and smell. Please keep them home.

Staff and participants will be verbally screened, using CDC required form, and temp checked each morning before entering Fab-You-Us! Use of hand sanitizer will be required upon entering before items are placed in designated area.

We will have a "Car Hop Style" drop off and pick up plan for participants:

We ask that scheduled participants remain in their car upon arrival until they are greeted by a masked and gloved staff member to collect CDC required screening form, daily forms and pens will be provided in advance to each participant as part of designated PPE Kits for the week at the beginning of each week of participation. Staff member will check participants temperature with a no contact thermometer and if temperature is below 100.4 and child is not experiencing symptoms of concern they will be asked to put on designated mask and/or face shield and will then be escorted inside to begin their day. Upon entering items brought from home will be placed in a designated bin and child will be required to use hand sanitizer or wash hands before play. When parent/guardian arrives for pick up we again ask that they remain in their vehicle. Our staff will notify your child to get ready for dismissal, they will be asked to wash hands or use hand sanitizer and then collect all items needed to leave with them. Face shields, and designated PPE will remain at Fab-YOU-Us! to be sanitized by a staff member and prepared for participants next visit.

Designated PPE kits and supplies

Each Participant will be provided a PPE Kit including a face shield, baseball cap to hold face shield, cloth masks, art supplies, and more. Masks and/or face shields will be required within guidelines when participants are unable to social distance 6 ft apart within "stable group". These designated supplies will only be used by that participant and will become the property of that participant on their last day of SUMMER FUN at fab-YOU-Us! These items will remain at Fab-YOU-Us! until their last day of participation in our SUMMER FUN Program. If a child takes home any of these supplies and then plans to return for additional sessions it will be the responsibility of their care provider to purchase new PPE for use at Fab-YOU-Us! These items will be cleaned and sanitized and prepared for next day of participation.

Hand Washing and Hand Sanitizer

Hand washing or use of hand sanitizer will be required of all staff members and participants but will not be limited to after toileting, after wiping a runny nose, after touching any bodily fluid, before and after using water, sand, or other sensory tables, after messy play, before any food preparation or service, and upon entry from the outdoors.

Groups and Social Distancing Phase 2 June 29th- at least July 31st

In this phase we plan to only register 15 participants who will be considered a "stable group", including staff, as defined by CDC as the same individuals, including children, staff, and counselors, being in the same group each day. These children will not have to social distance because they will be a "stable group". If more than 15 are registered or we are unable to provide a "stable group" daily we will create a second "stable groups", and designate areas to each group, and provide appropriate 14ft social distance between "stable groups" as required.

Cleaning and Disinfecting Toys, Games, Props, Materials used for Play

Bins will be provided to store toys, games, props, and play items after use at the end of each day and will be cleaned and disinfected before next use. Items will be available on a rotation to allow at least 24 hours between use. Participants will be required to wash hands before and after use of play items.

Cleaning and Disinfecting Fab-YOU-Us!

In addition to all rooms, areas, and play items at Fab-YOU-Us! being cleaned and disinfected at the end of each day additional housekeeping practices are being implemented throughout the day in our restrooms, high frequency areas, climbing structure, high touch areas including but not limited to door handles, bannisters, tables and chairs, and countertops.

Staff Policies

All staff members will be screened with temperature checks and COVID screening questions and will be wearing cloth face covering. Staff will have appropriate PPE when interacting with a child that needs assistance. Staff will be responsible to clean and disinfect throughout the day.

Temperature checks:

Temperatures will be checked 3 times a day and will be recorded by a staff member for each child upon arrival, before lunch and 3 pm. If at any point during the day child exhibits any symptoms that are concerning or reads a temperature that is higher than 100.4 a parent will be contacted and must make arrangements to pick up child within the hour. The child will be isolated with adult supervision until a parent/adult arrives. The child will be brought to the adult picking up the child. We may ask that you have your child tested within 48 hours. A decision will be made by facility director as to when child can return.

Response to COVID-19

To ensure the safety of our Fab-YOU-Us! Friends and families we will be paying close attention to all COVID-19 regulations, guidelines, and issues and will update our policies, practices, and procedures as needed.
